**PARTICIPATION FEE:** **Showcase fee is \$95** which includes a **non-refundable** \$55 participation fee plus a \$40 ticket fee (your ticket fee pays for two (2) total tickets to either show). The \$95 fee is payable via cash, Visa, AmEx or Mastercard, and must be submitted with this signed agreement. Your participation fee goes toward theater rental, rehearsal space fees, and faculty salaries. Students may participate in additional pieces, if there is space, for an additional fee of \$55 per piece (Please fill out an additional form and note second piece request). The \$55 fee does not include tickets.

**TICKETS:** Additional tickets may be purchased through the theater online or at the box office (available March 13) or the day of the show. *Both shows normally sell out; we highly recommend buying all tickets in advance.*

**ATTENDANCE POLICY:**

- **Class Attendance:** TBD by choreographer. You are encouraged to attend the choreographer's regularly scheduled classes.
- **Rehearsal Attendance:** Dates and times set by choreographer. Attendance is required at all scheduled rehearsals – any exceptions to be agreed upon between student and choreographer.
- **Tech & Show Attendance:** Performer must be available for the mandatory Tech and Show dates. If you cannot attend tech, please consult your choreographer. Tech times will be TBD by the choreographer.

**COSTUME FEE:** Choreographers may charge a costume fee not to exceed \$25. All participants are responsible for their own costumes.

**NO REFUNDS:** Failure to follow the above guidelines will forfeit your right to participate in the performance. There are no refunds.
